#### **SB 1229**

In our new age ever-changing vocabulary of new words like Facebook, Twitter, and all those Jersey Shore words, we all need to be aware of the SB word. It has to do with an Arizona SENATE BILL. These bills can drastically alter our way of life, personal freedoms and in my case getting my palm trees trimmed!

Chapter 1217 member and Arizona Pilots Association President Nancy Benscotter reports that a very important bill is in the State Senate that will continue to give us the freedom to operate our aircraft in areas other than airports. We have heard good news that the sponsorship of SB 1229 has agreed to add the language "operate aircraft" to SB 1229 in a quote from Nancy. This change will allow aircraft operators the same rights as hikers, hunters, and boaters, preventing us from being discriminated against when we want to land in the desert or on a lake.

Additional language offered by the Arizona Pilot's Association and Recreational Aviation Foundation for SB1229: "or" struck from between "vehicle" and "all-terrain" and add "or operation of aircraft" as shown in current text of bill below:

4. "Recreational user" means a person to whom permission has been granted or implied without the payment of an admission fee or any other consideration to travel across or to enter upon premises to hunt, fish, trap, camp, hike, ride, engage in off-highway vehicle, off-road recreational motor vehicle, or all-terrain vehicle activity, or operation of aircraft, exercise, swim or engage in similar outdoor recreational pursuits. The purchase of a state hunting, trapping or fishing license or a state trust land recreational permit is not the payment of an admission fee or any other consideration as provided in this section. A nominal fee that is charged by a public entity or a nonprofit corporation to offset the cost of

providing the educational or recreational premises and associated services does not constitute an admission fee or any other consideration as prescribed by this section.

#### **VULTURE MINE**

Chapter member Bernie Gross says the Vulture Mine Airstrip is available for landing again. When flying into the Vulture Mine Strip it is protocol to register at the mine office and leave a small 501.c3 donation.

Prior permission is not as yet totally required, but a user identifying courtesy phone call to the Mine Office, 602-469-7662, is a polite idea. They don't want unidentified or suspicious planes using the runway, and a quick phone call is all it takes.

Runway 15/33 (approximately 43.9 Miles West of DVT) 2100 ft msl, 3,000 ft + length N 33.49.502, W 112.49.661

Watch out for LUKE AFB SATR on 118.15 and/or 120.5 as depicted on the Phoenix Terminal Area Chart. Proper procedure is to drag the strip for a conditional inspection and then land uphill to the North on runway 35, right hand pattern suggested.

The owner of the mine is Todd Beal, 602-627 -8755 and appears to be reasonably cooperative.
