#### **GRAVES APPLAUDS FAA BILL**

On Apr 27, 2018, the U.S. House of Representatives, passed a long-term Federal Aviation Administration (FAA) reauthorization. Some of the major changes that can affect us are extending the aircraft registration period and allowing folks to build and restore planes in their hangars.

Congressman Sam Graves, who is a friend to pilots and an avid antique airplane collector himself, released the following statement:

"As a pilot and policymaker I've been interacting with people in the aviation community for more than two decades now," said Graves. "From daily conversations with fellow pilots to personal experiences I've had with the FAA, I understand the issues that face the industry. Today's passage will give the FAA and users of the systems five years of certainty – something that has been missing for too long. Moving forward, we are ensuring that all who rely on our air space can continue flying safely, securely and freely. America has always been a leader and pioneer in aviation since the days of the Wright Brothers and passage of this bill ensures that continues." The bill includes:

Guarantees \$1 billion for the small airport grant program which will result in an additional \$5 billion grant opportunities for airports over five-years.

Fix to FAA policy on receiving payment for living history flights. We are finally going to get this done and stop the rogue interpretations from FAA offices in the field.

Allow for more widespread testing of replacement fuels for AvGas.

Require the FAA to restore the 'all makes and models' certificate for pilots of experimental aircraft.

## Extend the aircraft registration period from 3 years to 10 years.

Require the FAA to mediate scheduling disputes between FAA approved airshows and major sporting events.

Expand state block grant authority from 10 to 20 states; my home state of Missouri uses this authority which allows states to have more control over the airport funds rather than the federal government. Prevent discriminatory taxes at airports that target certain industries like rental cars

Fix the hangar use issue by amending FAA guidance on aeronautical use to ensure construction of an aircraft in any stage is in compliance with grant assurances.

Require a report on the use of 'proprietary exclusive right' by airports.

Ensure that the Oklahoma Registry office is designated an 'essential government service' to ensure future Administrations don't play politics with aircraft registrations during a government shutdown

And to continue to help broker a compromise on tower marking requirements for our Ag Aviation folks to ensure they can continue to fly safely without fear of unmarked towers

#### CHANGE TO COMPLEX AIRCRAFT

In the past, the FAA has required applicants to provide a complex airplane for Commercial and Flight Instructor check rides. A complex plane being retractable gear, flaps, and a constant speed propeller. While the Commercial pilots still need ten hours of dual instruction in a complex plane they no longer have to show up with one for the check ride. It is estimated this will same applicants \$500on each rating.

Terry Emig provided the following information on the P-38L pictured above.

Rob Collings stopped for an overnight at CGZ in the Collings Foundations P-38L "Lightning" on Sunday, May 13<sup>th</sup>. He was returning from the Chino Air show by way of Oregon.

This P-38 was formerly on display at the Evergreen Museum in McMinnville, Oregon; after being restored at the Evergreen Facility at the Pinal Airpark in Marana, AZ.

According to Rob Collings it is the only P-38 still flying that still uses the original turbochargers which makes it very quiet due to the exhaust flowing through the turbos before exiting the exhaust stacks.

Other P-38 operators have removed the turbo wheel and directed the exhaust flow straight through into the exhaust stacks. This eliminates the need to maintain the turbo chargers which are not normally operated below 12,000 feet altitude.
