AIRCRAFT REGISTRATION EXTENDED

The FAA has released a rule that extends the duration of aircraft registration certificates from three years to seven years. According to the draft of the <u>direct final rule</u>, aircraft owners will be required to confirm their registration information and renew their certificates every seven years unless an event or circumstance requires a new registration before that time. If the agency determines that the registration information is inaccurate, an owner may be required to submit new registration forms.

In addition, the direct final rule further addresses a few other areas surrounding aircraft registration, including removing a requirement that the agency issue a letter extending temporary authorization if a registration has not been issued or denied within 90 days of the application. It also removes obsolete regulations addressing reregistration.

The agency in 2010 mandated that aircraft owners re-register their aircraft every three years. Before then, the registration period was indefinite, but with the stipulation that owners keep their registrations up-to-date. However, the agency found that owners failed to do so, creating a problem.

MORE GOOD NEWS FROM THE FAA

A new FAA directive is coming that eliminates the LODA requirements for receiving instruction in an experimental aircraft. Sec. 5604 of the <u>James M. Inhofe National Defense Authorization Act for Fiscal Year 2023</u> specifically addresses the issue:

"A flight instructor, registered owner, lessor, or lessee of an aircraft shall not be required to obtain a letter of deviation authority from the [FAA administrator] to allow, conduct, or receive flight training, checking and testing in an experimental aircraft if: 1) the flight instructor is not providing both the training and Continued on page 3

the aircraft; 2) no person advertises or broadly offers the aircraft as available for flight training, checking, or testing; and 3) no person receives compensation for use of the aircraft for a specific flight during which flight training, checking, or testing was received, other than for owning, expenses operating, maintaining the aircraft." In other words you can receive flight instruction such as a flight review in you experimental aircraft.

With the president's signature, experimental may resume aircraft owners receiving instruction in their aircraft without having to jump through this frustrating hoop.
